## **PRECEPT**

The clerk presented draft proposals for 2023 / 24. Discussed at length with the current Running Balance, especially the re-introduction of a VH Grant of £500 (withdrawn the previous year due to Covid Grant); 6.3% was agreed given the current national concerns due to rising energy and admin costs. (WNC restricted to 5% with no such limit for PCs, although this may change given financial pressures in the future). Last year was pegged at 2.3% and the projection of precept rise from £23,500 > £25,000 was justified and unanimously approved. The clerk to amend the draft to include the issues discussed and outlined.
